Progress on the existing targets/objectives contained within the current CAFS strategy and an assessment of their status

1. Introduction

- 1.1 This note provides background information on the current status of the targets contained within the current version of Cleaner Air for Scotland The Road to a Healthier Future (CAFS).
- 1.2 As CAFS was published in 2015 many of the timescales for actions were estimations and in some cases the timescales have had to be adjusted due to practicalities surrounding their completion.
- 1.3 Of the 40 actions originally contained with CAFS:
 - 14 actions are fully complete;
 - 2 actions are partially complete with components on hold or rescheduled;
 - 8 actions are ongoing and on schedule;
 - 1 action is partially ongoing and on schedule;
 - 12 actions are ongoing and on schedule with revised timescales;
 - 3 actions are fully on hold (but scheduled for completion by 2020).
 - Additional, complimentary, actions have been completed or are in progress which were not originally in CAFS.
- 1.4 All existing, incomplete, actions contained in CAFS are scheduled to be completed no later than 2020. These actions may be transferred into the next iteration of CAFS to be published later in 2019.
