The factors have been calculated using certified gas standards. The particulate analysers listed above have been tested for sample flow rates and k_0 (where appropriate) by documented methods. Note that the test results are valid on the day of test only, as analyser drift over time cannot be quantified. All results for gaseous species are given in ppb (parts per billion) mole fractions or ppm (parts per million) mole fractions.

¹The zero response is the zero reading on the data logging system of the analyser when audit zero gas was introduced to the analysers under test.

 $^{^2}$ The calibration factor is the multiplying factor required to scale the reading on the data logging system of the analyser into reported concentration units (ppb for NO, NO_x, SO₂, O₃ and ppm for CO. Where 1 ppm = 1000 ppb). It should be used in conjunction with the zero response. A corrected concentration is calculated using the following equation:

³Converter eff. is the measured efficiency of the NO₂ to NO converter within the oxides of nitrogen analyser under test.

⁴The measured main flow rate (where applicable) is the flow rate through the sensor unit of the TEOM particulate analyser under test. The measured aux flow rate (where applicable) is the flow rate through the bypass tubing of the TEOM particulate analyser under test. The measured total flow rate is the total flow rate through the particulate analyser under test. Units of flow are I.min-1. Where flow rates are highlighted in bold, it indicates that measurements were not made at the analyser sample inlet. These measurements therefore may not accurately reflect analyser performance in normal operation.

⁵The calculated k0 value (TEOM analysers only) is the calculated k0 spring constant based on tests undertaken with filters of known weight. The % deviation indicates the closeness of the calculated result to the manufacturer's specified k0 value.
