LAQM TOOLS UPDATED



SCOTTISH AIR QUALITY DATABASE AND WEBSITE ANNUAL SEMINAR — WEDNESDAY 10TH MARCH 2021 — PRESENTATIONS

Due to the Covid-19 restrictions, the 2021 Scottish Air Quality Database and Website Annual Seminar was carried out virtually over three 2-hour long webinars on:

CLEAN AIR DAY 2021



CLEAN Air Day celebrates its fifth birthday— the age when most young people start school — and this year's campaign is about protecting children's health from air pollution impacts.

Hundreds of pupils have made Scotland's national air quality campaign a success since the launch in 2017. From the Kintyre Peninsula to the Highlands, children have designed antipollution posters, organised playground air quality experiments and marched, singing their hearts out, through Edinburgh and Glasgow air quality placards.

Environmental Protection Scotland is once again coordinating Clean Air Day on behalf of the Scottish Government on 17th June. The campaign will ask people to leave the car at home, especially for shorter trips, walk or cycle quieter side streets to minimise exposure to air pollution and to consider buying an Ultra Low Emission Vehicle.



Engine idling, especially outside schools, is another important campaign message and motorists can help improve local air quality by only ordering essential deliveries or using cargo bikes.

With vehicle use significant reduced during the first national lockdown last year, there were remarkable short-term gains for air quality. As we return to our normal daily lives, Clean Air Day will ask people to take the opportunity to build a healthy environment for our children.

SAQD QAQC ACTIVITIES

Ricardo will begin the routine six monthly summer audits this month (June). Ricardo will contact each local authority in advance to confirm the date of the scheduled audit. Ricardo are continuing to adhere to the 72-hour rule for Covid-19, please inform Ricardo if your council or Engineer Support Units (ESU) have been to site within this period.

QUESTION AND ANSWERS SECTION

This section will provide answers to frequently asked questions that relate to different aspects of LAQM ranging from Local Site Operator (LSO) duties to advanced data analysis queries. If you have a question you would like to be answered in this section, please contact aq-monitoring-scotland@ricardo.com.

- Q. Can local authorities still use the ratified 2020 monitoring data for upcoming Dispersion Modelling Verification?
- A: No, the Scottish Government advises the use of 2019 monitoring data for model verification.
- Q: Will the Annual Progress Report deadline be changed in 2021 due to limited resources?
- A: The Scottish Government is aware that measures in place to combat the spread of Covid-19 may have impacted local authority resource for air quality work and therefore may cause delays in reporting. The statutory deadline of 30th June for the year 2021 will remain but we will take a flexible and realistic approach when there is a risk that this deadline may be missed. The Scottish Government ask authorities write to them if they require an extension due to Covid-19 for 2021 reporting, so they can consider and respond to requests based on the specific circumstances of each local authority. They will ask local authorities to do so by emailing andrew.taylor2@gov.scot, copying in tanith.allinson@gov.scot outlining how resources have been impacted and the extension they wish to apply for. Each request will be considered on a case by case basis.
- Q. Will COVID-19 have an impact on any upcoming Air Quality Management Area (AQMA) actions i.e. revocation cases?
- A: The Scottish Government recognise that air pollutant concentrations may have been significantly impacted by the change in activity observed across Scotland and the rest of the UK as a result of Covid-19 and associated measures.

This may have led to compliance with air quality objectives in Air Quality Management Areas (AQMAs) in the year 2020. The Scottish Government's current guidance states that monitoring data should show compliance with objectives over a minimum period of three consecutive years when considering the revocation of an AQMA, as well as national trends in emissions and measures introduced as part of an Air Quality Action Plan. Any revocations being currently taken forward or planned on the basis of pre 2020 data should continue. The suitability of 2020 datasets as part of the evidence base for future revocations will be considered on a case by case basis.
